

Terms and Conditions of Entry

2019 Pharmacy Assistant National Conference Facebook Competition to Win a Registration Plus 2 Nights' Accommodation at Sofitel Brisbane Central

1. Information on how to enter and prize details form part of these conditions. Entry into this Promotion is deemed acceptance of these terms and conditions of entry.

3. The Promotion will be open from **8:00 am AEST on Tuesday, 10 September 2019** and will continue until **11.59 pm AEST on Sunday, 22 September 2019 (Promotion Period)**.
4. Entry is open to all **Australian** residents aged **18 years and over** who currently work in a pharmacy other than management, employees or contractors of the Promoter and other agencies, firms or companies associated with the Promotion (including suppliers of prizes), and their immediate families (**Eligible Entrants**).
